III. Fall State Meet November 18-19, 2011

- A. Flyer was sent out by e-mail. Expecting approximately 200+ gymnasts.
- B. Sessions will take place as follows:
 - a. November 18: Session 1 Level 5
Session 2 Level 5
 - November 19: Session 3 Level 3 (if enough athletes entered...if not may be combined with a Level 4 session.)
 - Session 4: Level 4
 - Session 5: Level 4
 - Session 6: Level 6
- C. Judges for Fall State Meet were voted on and Heather will send the names to NAWGJ to be contracted.

IV. Updates to the State Handbook were discussed and voted on. We will have a link on the website with a printable version as soon as it is updated. Hard copies will be available as well.

- A. State Calendar issues were discussed. The committee does not dictate when you can run a meet. Anyone can place a meet on the calendar. We went to a draw so all clubs would have a chance to place a meet on the calendar. We will be sending out a survey to get the club's feedback on how we can have an organized competition season and calendar in place for our state. The committee proposed some options regarding Invitationals being run in an outside facility that want to be placed on the calendar before the draw. Concern is that before it is placed on the calendar that a contract should be in place for the outside facility.
- B. Entry fees. Proposed that we increase the entry fee for Optional State Meet to 100.00 per athlete. (Contingent on approval from RACC). Cathy will send the financial from Optional State for approval. Also, proposing to raise the entry fee for XCEL's to 85.00 for State Meet.
- C. Gate Fees will remain in effect as written.
- D. A few additions will be made to the Criteria for judges.
- E. No changes will be made to the State Meet Host Responsibilities.
- F. We will be adding a State Meet Bid process page.

- G. Printable State Club List will be placed as a link and will be available to print as labels.
- H. No changes were made to the State Qualifying Procedures. Level 4's and 5's must be in 3 IN-state sanctioned meets judged by a 2 judge panel. Level 3's and 6's must compete in 1 In-state Meet.
